WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

William V. Nery	General Services	\$ 1,000	Mr. Nery is an Equipment Repair Supervisor in the Equipment Division. He suggested that coolant recovery systems be installed on the City's compact vehicles. This is expected to save \$17,462 in the first year in time and equipment. This is a partial award pending a final 12 month review.
David L. Gerber	General Services	\$ 1,000	Mr. Gerber was a Refrigeration Mechanic in the Buildings Division. He suggested that a new control panel be installed on the Trane absorption air conditioning unit at the Central Police Station. The first year's savings as a result of this suggestion were estimated to be \$10,697 in time and energy costs.
Walter R. Newbern	Engineering & Development	\$ 555	Mr. Newbern is an Associate Land Surveyor in the Survey Section. One year ago he earned a partial award of \$345 for his suggestion to discontinue keeping independent time-cost records on surveys done. One year's experience has shown a savings of \$2,994. This is the remainder of his award.
