Aldo Chiappone	Water Utilities	\$ 380	Mr. Chiappone is a Plant Maintenance Mechanic in the Metro Wastewater Division. He suggested that unused pits in the main pipe gallery at the Point Loma Treatment Plant be capped. This is expected to save \$3,810 in the first year in labor costs.
Robert Snowden Jim Phillips Tony Clews Desmond Marmion Dave Darnell	General Services	\$ 365	Messrs. Snowden, Phillips, Clews, Marmion and Darnell are supervisors in the Litter Enforcement Section of the Streets Division. One year ago they earned a partial award of \$75 for their suggestion to fill the front tires on the Case tractors with polyurethane foam. One year's experience has shown a savings of \$4,375. This is the remainder of their award.
Jim D. Slade Frank Kennaly	General Services	\$ 360	Mr. Slade is a Building Maintenance Supervisor and Mr. Kennaly is a Painter in the Buildings Division. One year ago they earned a partial award of \$400 for their suggestion to purchase a Paint Tinting Machine for use in the Buildings Division. One year's experience has shown a savings of \$7,585. This is the remainder of their award.
Susan E. Roos	Police	\$ 300	Ms. Roos is a Senior Clerk in the Records Division. She suggested that information from the Hit & Run Worksheet no longer be transferred to the Traffic Collision Report by Records Personnel. This is expected to save \$2,060 in the first year in labor costs. This is a partial award pending a final 12 month review.
