WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Walter A. Gray	Engineering & Development	\$ 270	Mr. Gray is a Senior Engineering Aide. He suggested that the procedure for numbering and processing Encroachment Permits be modified. This is expected to save \$1,818 in the first year in labor costs.
Jack L. Hoffelt	Park & Recreation	\$ 255	Mr. Hoffelt is a Recreation Caretaker in the Eastern Division. He suggested that a dolly which he designed be utilized for moving folding tables. This is expected to save \$684 in the first year in labor costs. This is a partial award pending a final 12 month review.
Thomas A. Wormington	General Services	\$ 240	Mr. Wormington is an Electrician in the Buildings Division. One year ago he earned a partial award of \$165 for his suggestion to install exit sign guards which he designed in City gymnasiums. One year's experience has shown a savings of \$4,052. This is the remainder of his award.
William C. Pontsler	General Services	\$ 220	Mr. Pontsler is an Electrician Supervisor in the Buildings Division. One year ago he earned a partial award of \$155 for his suggestion to use energy saving ballasts in City buildings. One year's experience has shown a savings of \$3,760. This is the remainder of his award.
Jeffrey L. Frankhouser	General Services	\$ 205	Mr. Frankhouser is an Equipment Mechanic in the Equipment Division. He suggested that two tools be utilized to simplify cylinder head removal. This is expected to save \$687 in the first year in labor costs.
