

RESOLUTION NO. R-254715Adopted on JUL 28 1981

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
George Ikeda Stephie Aceves	General Services	\$ 175	Mr. Ikeda is a Carpenter and Ms. Aceves is an Intermediate Typist in the Buildings Division. They designed and constructed a cabinet to simplify the entry and storage of labor and vehicle computer cards. This is expected to save \$589 in the first year in labor costs.
Daniel Karsh	Police	\$ 170	Mr. Karsh is a Sergeant in the Traffic Division. He suggested that the Records Division discontinue sending copies of the Traffic Warrant arrest reports to Traffic Division. This is expected to save \$1,156 in the first year in time and material.
Susan E. Roos	Police	\$ 150	Ms. Roos is a Senior Clerk in the Records Division. One year ago she earned a partial award of \$125 for her suggestion to reuse Accident Report jackets. One year's experience has shown a savings of \$920. This is the remainder of her award.
William C. Adams	Fire	\$ 150	Mr. Adams is a Fire Engineer. He suggested that a swing-out shelf which he designed and constructed be installed on the fire apparatus to carry the Hurst Tool. Although savings were difficult to estimate, this was considered to be a significant safety improvement.
Patricia A. Young	General Services	\$ 145	Ms. Young is an Intermediate Typist in the Buildings Division. She suggested that forms used in the Work Control Center be printed rather than photocopied. This is expected to save \$488 in the first year in material costs.
