

RESOLUTION NO. R-254716

Adopted on JUL 28 1981

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

| <u>NAME</u>       | <u>DEPARTMENT</u> | <u>AMOUNT</u> | <u>SUGGESTION</u>  |
|-------------------|-------------------|---------------|--|
| Michael O. Ansel  | Police            | \$ 120        | Mr. Ansel is an Auto Messenger in the Records Division. He suggested that postage due mail be refused by the Police Department. This is expected to save \$402 in the first year in time and material.   |
| Daniel Karsh      | Police            | \$ 120        | Mr. Karsh is a Sergeant in the Traffic Division. He suggested that the practice of filling out parking citation book tags be discontinued. This is expected to save \$394 in the first year in labor costs.  |
| Glenn D. Cheek    | Fire              | \$ 100        | Mr. Cheek is a Fire Engineer. He suggested that reflective street markers be installed to identify the location of fire hydrants. Although savings were difficult to calculate, this was considered to be a significant public safety improvement.   |
| David R. Jacks    | General Services  | \$ 95         | Mr. Jacks is an Equipment Mechanic Apprentice in the Equipment Division. One year ago he earned a partial award of \$80 for his suggestion to replace the lubrication plugs on Ford Couriers with grease fittings. One year's experience has shown a savings of \$1,773. This is the remainder of his award. |
| Robert C. Frajman | General Services  | \$ 50         | Mr. Frajman is an Electrician in the Buildings Division. He suggested that metal screen be installed around the Pump Station #2 exhaust fan discharge pipe. Although savings were difficult to identify, this was considered to be a significant operational improvement.                                    |
