WHEREAS, the Library Department is conducting a major program to convert its records into machine readable forms as an initial step in developing an automated library system; and

WHEREAS, a large part of staff involved in this effort are currently CETA funded and the City has been advised that CETA funding will end on September 30, 1981; and

WHEREAS, in order to continue the conversion effort through the end of fiscal year 1982, alternate sources of funding are required; and

WHEREAS, the City Council appropriated \$500,000 in May, 1979, for the purpose of implementing an automated library system; and

WHEREAS, it is now deemed desirable and appropriate to transfer the sum of \$115,000 from this previously appropriated money from non-personal expense to personal expense in order to fund 11.25 full-time equivalent PSCT Junior Typists - Limited through the end of fiscal year 1982; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the City Auditor and Comptroller be and he is hereby authorized to transfer within Department 901 the sum of \$115,000 from Non-Personal expense to Personal expense for the purpose of funding 11.25 full-time equivalent PSCT Junior Typists - Limited through the end of fiscal year 1982 in order to complete conversion of records in the development of an automated library system.
