BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized to enter into an agreement with Hope San Diego for an architectural concept study for expansion of San Diego Jack Murphy Stadium for a sum not to exceed \$8,000.00.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized to enter into an agreement with Price Waterhouse and Company to perform certain financial studies in connection with expansion of San Diego Jack Murphy Stadium for a sum not to exceed \$10,000.00.
