

RESOLUTION NUMBER R- 254756

Adopted on AUG 4 1981

WHEREAS, the Federal Disaster Relief Act of 1974 provides for reimbursement to local governments of one hundred percent (100%) of eligible costs of reconstructing or repairing facilities damaged by disasters; and

WHEREAS, H.R.3537 would amend the Disaster Relief Act of 1974 to require local governments to contribute twenty-five percent (25%) of the costs of disaster recovery; and

WHEREAS, local governments are now contributing substantial sums to the total cost of disaster recovery; and

WHEREAS, local governments in California, as elsewhere, are faced with severe fiscal constraints, and in case of a major disaster requiring large sums for disaster relief would be unable to fund the twenty-five percent (25%) local share thereby losing entitlement to any federal disaster relief; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council opposes the passage of H.R.3537 and urges the House of Representatives to defeat this bill.
