

RESOLUTION No. R-254763

(R- 82-76)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. ROYAL BUSINESS MACHINES INC., 2. NELOWET BUSINESS MACHINES, 3. IBM CORPORATION, and 4. EASTMAN KODAK are hereby accepted and the City Manager is hereby authorized to execute contracts for the RENTAL OF COPIERS AND DUPLICATORS, and copier supplies as may be required per prices on file in the Purchasing Department, with the option to rent additional equipment of the same model, at the same rates, as follows:

1. ROYAL BUSINESS MACHINES INC. for Items 2, 3, 5, 7, 9, 25, 28, and 29 providing that Item 29 be located in the Convention and Performing Arts Center Office rather than the address on the bid, for a period beginning with date of installation through June 30, 1982, terms net plus sales tax;
2. NELOWET BUSINESS MACHINES for Item 10 for a period beginning with date of installation through June 30, 1982, terms net plus sales tax;
3. IBM CORPORATION for Items 13, 15, 16, 18, 21, 22, 23, and 24 for a period beginning July 1, 1981 or date of installation, whichever is later, through June 30, 1983, with the City's option to terminate any item June 30, 1982 should funds not be appropriated, terms net plus sales tax;
4. EASTMAN KODAK for Items 19, 20, and 26 for a period beginning July 1, 1981 or date of installation, whichever is later, through June 30, 1983, with the City's option to terminate any item June 30, 1982 should funds not be appropriated, terms net plus sales tax; and
5. EASTMAN KODAK for Item 17 for a period beginning July 1, 1981 through June 30, 1982, terms net plus sales tax.
