BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. R-254768, quitclaiming to HOME SAVINGS AND LOAN ASSOCIATION, a California corporation, all the City's right, title and interest in the drain easement, as more particularly described in said quitclaim deed.
