
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized to enter into an agreement with Envirotech Corporation, for services of electronic technicians to install, calibrate, test, diagnose and repair various instruments and installations at the Point Loma Treatment Plant and Pump Stations I and II from July 1, 1981 to June 30, 1982 for a sum not to exceed \$132,000.

BE IT FURTHER RESOLVED, that the expenditure of \$132,000 for this program is hereby authorized out of Utilities Sewer Fund 41506 for the sole and exclusive purpose of providing funds for the above services.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$65,000 within the 41506 fund from the Unallocated Reserve (70679) to Maintenance, Point Loma Treatment Plant (70235).




