

RESOLUTION OF THE CITY COUNCIL, THE CITY OF SAN DIEGO,
CALIFORNIA, ABANDONING PROCEEDINGS

(ALBERTA CANYON PARK DISTRICT - PARK DISTRICT NO. 592)

WHEREAS, the City Council of the City of San Diego, California, has heretofore instituted proceedings pursuant to the provisions of Division 8 of the San Diego Park District Procedural Ordinance of 1969, as amended (San Diego Municipal Code Section 61.0601 et seq.), for the acquisition of certain open space lands in the City for park and recreation purposes; and

WHEREAS, pursuant to the provisions of said ordinance the hearing has been duly and regularly held on August 10, 1981, the matter having been continued to said date from August 4, 1981, upon Resolution of Intention No. R-254557 of the City Council and upon the Report for the proposed acquisition prepared pursuant thereto; and

WHEREAS, certain written protests and objections have been filed by the owners of property to be assessed, and the City Manager has reported to the Council that said written protests and objections were filed by the owners representing a majority of the area proposed to be assessed; NOW, THEREFORE,

BE IT RESOLVED by the City Council of the City of San Diego, California, as follows:

Section 1. All proceedings heretofore had and taken by the City Council for the acquisition referred to above, shall be and the same are hereby abandoned.

Section 2. The City Clerk is hereby authorized and directed to record a

certified copy of this Resolution with the County Recorder and to index this Resolution in the book containing the index of the maps of assessment districts, as provided in Section 3117 of the Streets and Highways Code.


