

RESOLUTION NUMBER R- 254815

A RESOLUTION ELECTING TO PROCEED UNDER THE PROVISIONS OF THE PUBLIC STREETS, HIGHWAYS, AND SERVICE EASEMENTS VACATION LAW, DECLARING THE INTENTION OF THE CITY COUNCIL TO VACATE A PORTION OF OPEN SPACE EASEMENT IN LOT 73 OF LUSK INDUSTRIAL PARK UNIT 1, MAP 9694, AND FIXING A TIME AND PLACE FOR HEARING THEREOF.

BE IT RESOLVED, by the Council of The City of San Diego, that the public interest and convenience of said City require the vacation of a portion of open space easement in Lot 73 of Lusk Industrial Park Unit 1, Map 9694, hereinafter mentioned; and

BE IT FURTHER RESOLVED, that it is the intention of said Council to order the vacation of a portion of open space easement in Lot 73 of Lusk Industrial Park Unit 1, Map 9694, as more particularly shown on Drawing No. 15357-B on file in the office of the City Clerk as Document No. RR- 254815 .

The Council hereby elects to proceed, in making said vacation under the provisions of the "Public Streets, Highways, and Service Easements Vacation Law."



That The Daily Transcript, a daily newspaper published and circulated and of general circulation, in said City of San Diego, be, and it is hereby designated as the newspaper in which the Street Superintendent of said City shall cause to be published, in the manner and form required by law, notice of the passage of this Resolution of Intention, and the Street Superintendent is

hereby directed to cause notices of the passage of this resolution to be posted in the manner and form required by law and to cause a notice similar in substance to be published in said newspaper in the manner required by law.
