PLANNED RESIDENTIAL DEVELOPMENT PERMIT NO. 125/EXTENSION OF TIME NO. 2

WHEREAS, said appeal was set for public hearing on August 18, 1981; and

WHEREAS, the Council of The City of San Diego received for its consideration documentary, written and oral testimony and heard from all interested parties present at the public hearing; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That said Council finds that there has been a material change of circumstances since the permit was originally granted, as set forth in Planning Report No. 81-326, 81-334 and 81-335, dated June 19, 1981, on page 2, "Analysis."

That said finding is supported by the minutes, maps and exhibits, all of which are herein incorporated by reference.

BE IT FURTHER RESOLVED, that the appeal of MICHAEL SANDOVAL is denied and this Council does hereby deny to SANDOVAL CONSTRUCTION, INC. Planned Residential Development Permit No. 125/Extension of Time No. 2.
