RESOLUTION NUMBER R- 254861

Adopted on AUG 24 1981

WHEREAS, Senate Bill 178 would establish a new, non-refundable credit which could be claimed for the cost of converting cars or trucks to the use of an alcohol fuel; and

WHEREAS, under existing law, taxpayers are allowed to claim various credits against their tax liabilities; and

WHEREAS, this Bill (SB 178) establishes a 55 percent tax credit for the cost of converting vehicles to the use of an alcohol fuel such as methanol or ethanol, with a maximum credit of \$1,000; and

WHEREAS, the Bill further provides for a reduction in the State credit whenever the combination of State and Federal credits exceed 55 percent; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, after due deliberation of the merits of the proposal, does hereby express its support for Senate Bill 178 (Boatwright) relating to tax credits.
