

RESOLUTION NUMBER R- 254862

Adopted on AUG 24 1981

WHEREAS, present law prohibits the possession of any device or paraphernalia used for unlawfully injecting or smoking certain controlled substances but not including marijuana; and

WHEREAS, Senate Bill 341 extends the law by making it a criminal offense for any person to use or possess with intent to use, such devices and paraphernalia, including marijuana; and

WHEREAS, SB 341 provides further that any violation as specified above by the holder of a business or liquor license issued by a local or state governing entity in the course of the licensee's business shall be grounds for the revocation of such license; and

WHEREAS, it is deemed vital to the health, safety and welfare of all persons that tight controls be implemented upon the possession, sale and use of such drug paraphernalia; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of itself and the people of the City of San Diego, does hereby express its support for Senate Bill 341 relating to drug paraphernalia and does hereby urge favorable action upon said bill by the California Legislature.
