RESOLUTION NUMBER R- 254865

Adopted on AUG 24 1981

WHEREAS, a significant number of Indochinese refugees have resettled in the San Diego area; and

WHEREAS, serious concern has been expressed regarding tuberculin testing for a great number of those refugees; and

WHEREAS, current estimates indicated that 13,260 Indochinese refugees are in need of tuberculin testing; and

WHEREAS, it is further estimated a large percentage of those refugees to be tested would have positive reactions and require further treatment; and

WHEREAS, funds presently received by the County Health Department for this purpose are insufficient and it is necessary for the health, safety and welfare of the community that additional funds be allocated to accomplish a complete testing program; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that this Council, for and on behalf of the people of San Diego, does hereby request the Federal Government to make additional funds available to assist the County of San Diego in administering its tuberculosis screening program for Indochinese immigrants residing in the County.

BE IT FURTHER RESOLVED that the County Board of Supervisors are urged to also request from the Federal Government additional federal assistance for this program.
