## RESOLUTION NO. R-254875 (R-82-296) AUG 24 1981

WHEREAS, on January 28, 1980, the City Council adopted Ordinance No. 0-15174 which gave the San Diego Fire Department the authority to inspect private properties to cause owners to clean up and remove overgrown weeds, grass, brush and/or rubbish and combustible waste; and

WHEREAS, Fire Department personnel have completed the inspection phase and have notified owners of the existence of hazardous conditions on their properties; and

WHEREAS, sufficient time, a minimum of 30 days, has been granted and elapsed for each owner to successfully perform cleanup operations on said properties; and

WHEREAS, the number of properties identified as being in violation total 1,704 private properties and 85 belonging to the City and other governmental agencies; and

WHEREAS, as of August 13, 1981, 1,041 parcels have complied and 663 parcels have not complied; and

WHEREAS, it is estimated that 300 parcels will require abatement by the City and funds allocated for that purpose, said funds to be recovered through a billing process or property tax lien process; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the expenditure of \$200,000 is hereby authorized from the General Fund (Fund 100) for the abatement of weeds,

grass, brush and rubbish from private properties, by private contractors, that have been declared a nuisance and/or a fire hazard by the Fire Department persuant to Ordinance No. 0-15174.
