

RESOLUTION No. R-251878

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$1,501,135.50 by METRO-YOUNG CONSTRUCTION CO., A DIVISION OF OLSON CONSTRUCTION CO., a corporation, for THE CONSTRUCTION OF HARBOR DRIVE REALIGNMENT BETWEEN PACIFIC HIGHWAY AND FIFTH AVENUE, Base Bid and Alternate Connection No. 2 in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the specifications on file in the office of the City Clerk as Document No. A-00242.
2. That the City Auditor and Comptroller is hereby authorized to transfer \$26,800.00 from Capital Outlay Fund 30245, CIP 11-178 San Miguel Drain and \$30,537.00 from Capital Outlay Reserve CIP 90-245 to CIP 52-203.1 Harbor Drive Realignment.
3. That the contribution of \$435,205.00 from the San Diego Unified Port District for a portion of the work of the construction of Harbor Drive Realignment is hereby accepted.
4. That the expenditure of \$1,172,337.00 from Capital Outlay Fund 30245, CIP 52-203.1 Harbor Drive; \$435,205.00 from Private Contribution Trust Fund 63022; and \$226,166.00 from Water Revenue Fund 41502 Water Main Replacements CIP 73-083 of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs.
5. That the City Manager is hereby authorized to execute the RIGHT OF ENTRY LICENSE with the Atchison, Topeka and Santa Fe Railroad Co. and the CONTRACTOR'S RIGHT OF ENTRY AGREEMENT with the San Diego and Arizona Eastern Transportation Co. for the purposes of accomplishing the work within the rights-of-way of the respective railroads.
