| Nolan Howard | Water Utilities | \$ 2,120 | Mr. Howard is an Equipment Technician II in the Systems Division. He suggested that sludge line air valve parts be coated with electrical resin. This greatly reduces blockages and reduces the time spent on preventive maintenance. This is expected to save \$7,066 in the first year in costs for time, material and equipment. |
| Ben D. Romero, Jr. | Water Utilities | \$ 1,000 | Mr. Romero is a Senior Utility Supervisor in the Systems Division. He suggested that a 30" overflow lateral be installed at the Sorrento Valley Boulevard sewer manhole. This is expected to save well in excess of \$35,000 in time, material, equipment and claims. |
| Rodger A. Blakey | General Services | \$ 855 | Mr. Blakey is a Sign Painter in the Streets Division. He suggested that high impact styren plastic be used for small sign jobs. This is expected to save \$5,720 in the first year in time and material. This is a partial award pending a final 12 month review. |
