Robert L. Davis	General Services	\$ 375	Mr. Davis was a Plumber in the Buildings Division at the time of his suggestion. One year ago he earned a partial award of \$320 for his suggestion to install an outside temperature control on the 20th and B boiler. One year's experience has shown a savings of \$2,323. This is the remainder of his award.
George R. Ikeda	General Services	\$ 215	Mr. Ikeda is a Carpenter in the Buildings Division. He suggested that a t-square saw fence be purchased to replace the existing saw guide. This is expected to save \$710 in the first year in labor costs.
Patricia J. DiGiacomo	City Treasurer	\$ 170	Ms. DiGiacomo is a Senior Typist. One year ago she earned a partial award of \$70 for her suggestion to copy referral cards rather than type information on a separate listing. One year's experience has shown a savings of \$2,388. This is the remainder of her award.
Frances C. Wyborney	Library	\$ 130	Ms. Wyborney is an Intermediate Typist. One year ago she earned a partial award of \$120 for her suggestion to revise the overdue notice. One year's experience has shown a savings of \$2,523. This is the remainder of her award.
Edward J. Zitter	Police	\$ 125	Mr. Zitter is a Sergeant. He suggested that juvenile records for aliens and Youth Authority parolees be purged when they reach the age of 18. This is expected to save \$425 in the first year in labor costs.
