WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Paul G. Zielins	General Services	\$ 110	Mr. Zielins is an Equipment Mechanic in the Equipment Division. He suggested that a tool be fabricated for the removal and return of Leach packing blade rams. This is expected to save \$372 in the first year in labor costs.
Rose L. Leary	City Clerk	\$ 95	Ms. Leary is a Administrative Aide II. One year ago she earned a partial award of \$95 for her suggestion to eliminate nine copies of Council Meeting exhibit packages. One year's experience has shown a savings of \$1,896. This is the remainder of her award.
James J. Darrach	General Services	\$ 50	Mr. Darrach is a Communications Technician in the Communications and Electricial Division. He suggested that plastic sheets be placed over radio circuit boards in Police vehicles. This is expected to save \$167 in the first year in costs for labor and equipment.
Francis A. Devlin	Water Utilities	\$ 25	Mr. Devlin is an Equipment Operator I in the Systems Division. He suggested that a reconditioning program for barricades be implemented. Although savings were difficult to identify, this was considered to be a significant operational improvement.
Chuck E. Lundy	Water Utilities	\$ 25	Mr. Lundy is a Welder in the Systems Division. He suggested that an arc gouging torch be purchased for repairing cracked welds and faulty casting. Although savings were difficult to identify, this was considered to be a significant operational improvement.
