Patricia L. Page	Water Utilities	\$ 25	Ms. Page is a Waste Water Plant Operator Trainee in the Quality Division. She suggested that a storage cabinet be constructed for drill motors and equipment. Although savings were difficult to estimate, this was considered to be a significant safety improvement.
Lorna M. Murt	Engineering & Development	\$ 20	Ms. Murt is an Intermediate Stenographer. She suggested that an index be added to the City Offices telephone directory. Although savings were difficult to identify, this was considered to be a significant operational improvement.
