RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO,  
CALIFORNIA, AWARDING CONSTRUCTION CONTRACT FOR WORK  
AND IMPROVEMENTS

(Assessment District No. 3970 - Carroll Canyon Centre)

WHEREAS, the City Council of the City of San Diego has invited bids for the construction of certain public improvements, appurtenances, and appurtenant work within and related to an area of the City designated as Assessment District No. 3970 - Carroll Canyon Centre, pursuant to Resolution of Intention No. R- 254672 adopted on JUL 21 1981, and the Report prepared pursuant thereto, which Resolution of Intention and Report are hereby referred to for a description of said public improvements and for all particulars relative to the proceedings under said Resolution of Intention; and

WHEREAS, the Purchasing Agent of the City of San Diego did on AUG 21 1981 publicly open, examine, and declare all sealed bids for doing said public improvements, and thereafter reported the same to the City Council; and

WHEREAS, the bid of R. E. Hazard Contracting Co. was the lowest regular bid submitted by a responsible bidder in accordance with the Notice Inviting Bids, and is acceptable to the Council;

NOW, THEREFORE, the City Council of the City of San Diego, State of California, DOES HEREBY FIND, RESOLVE, DETERMINE, AND ORDER as follows:

Section 1. The Council hereby rejects all of said bids except that hereinafter mentioned, and hereby awards the contract for doing said public improvements to the lowest responsible bidder, to wit: R. E. Hazard Contracting Co.

\_\_\_\_\_ at the prices named in the bid of said bidder on file in the Office of the City Clerk of the City.

Section 2. The appropriate City officials are hereby authorized and directed to take such actions as they deem necessary and proper to effectuate and consummate said contract.

Section 3. Subject to the right of the property owners to elect to take the work as provided in Section 10502.2, Streets and Highways Code, the bidder above-named shall be required, within 15 days after written notice that the contract has been awarded to him, to enter into a contract with the City for said work, and to post the surety bonds as provided for in the Contract Documents for said work.

Section 4. In the event said contract and bonds are not executed and filed within the time prescribed, then the bid bond, check, or other security accompanying the bid of the aforesaid low bidder shall be forfeited to the City.

Section 5. An executed copy of the contract and said bonds shall be filed in the Office of the City Clerk.

Section 6. The City Clerk is hereby authorized and directed to publish a Notice of Award of the contract as provided in Section 10502.1, Streets and Highways Code.

Section 7. All actions heretofore taken in connection with the awarding of the contract and other matters related thereto are hereby approved, ratified, and confirmed.
