

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of COLADA CORPORATION, N.V., a Netherlands Antilles corporation, executed in favor of The City of San Diego, bearing date of July 6, 1981, granting to said City an easement for public street purposes over, along, and across a 2 foot wide strip of land being a portion of the West half of Lot 3 of the Southeast Quarter of the Southwest Quarter of Section 10, Township 15 of South Range 3 West, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed for public street purposes is hereby dedicated as and for a public street, and the same is hereby named MIRAMAR ROAD.

That the City Clerk is hereby authorized and directed to cause said deed and a certified copy of this resolution attested by him under seal, to be recorded in the office of the County Recorder.
