

RESOLUTION NO. R-254933

(R. 82-066)

WHEREAS, the City of San Diego supports and is deeply appreciative of the volunteer efforts of its citizens; and **AUG 31 1981**

WHEREAS, the City recognizes its obligation to provide compensation to those individuals volunteering services, who might be injured while performing such public service; and

WHEREAS, Section 3363.5 of the California Labor Code provides for worker compensation coverage for such individuals upon an affirmative resolution of this Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City of San Diego does hereby adopt Section 3363.5 of the Labor Code insofar as the provisions of such law shall be solely applicable to those individuals whose offer of uncompensated service has been accepted as part of a recognized volunteer program.

BE IT FURTHER RESOLVED, the City Manager be and he is hereby authorized to promulgate a list of those volunteer programs recognized by the City of San Diego, to identify those volunteers currently participating in those programs, and that he provide each new volunteer with an appropriate enrollment form.
