A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO, CALIFORNIA, SUPPORTING CONSTRUCTION OF THE PERIPHERAL CANAL PROJECT UNDER THE PLAN PROPOSED BY SENATE BILL 200.

WHEREAS, the U. S. Supreme Court has ruled that by 1985 Southern California's supply of water from the Colorado River will be cut in half; and WHEREAS, the increasing possibility of serious water shortages within the next decade is a source of continuing concern to all residents and businesses in the City of San Diego and throughout Southern California; and WHEREAS, the construction of the Peripheral Canal would assure a stablized quality of water not now enjoyed by State Water Project Contractors and permit Southern California water utilities to commit funds to waste water reclamation, thereby reducing both long-term demands for water and providing insurance against the effects of drought; and

WHEREAS, the City of San Diego and attendant municipal entities and representatives are extremely concerned over the failure to start the long-delayed project; and

WHEREAS, the timely development of the Peripheral Canal Project is necessary to ensure the future orderly growth and development of San Diego's and all of Southern California's business, agriculture, and industry; and once agreement is reached, it will take many years to complete the work necessary to open such a canal; NOW, THEREFORE,

BE IT RESOLVED that the City Council of the City of San Diego does support

the construction of the Peripheral Canal Project under the plan proposed by Senate Bill 200, and urges all voters to support this project by voting in favor of it at the June 1982 election.
