BE IT RESOLVED, by the Council of The City of San Diego as follows:
Said Council hereby finds that certain map surveyed by LEROY C. BODAS, a
Registered Civil engineer, entitled "VILLA MESA UNIT NO. 1 Being a subdivision
of a portion of Parcels 2 and 3, as shown on Parcel Map No. 8547, filed in the
office of the County Recorder of San Diego County, March 19, 1979, in the City
of San Diego, County of San Diego, State of California.," is made in the manner
and form prescribed by law and conforms to the surrounding surveys; that said
map and the subdivision of land shown thereon is hereby approved and accepted;
and said Council hereby accepts on behalf of the public, the following: Via
Septimo, Via Maltaso and a portion of Antigua Boulevard for public purposes,
and said streets and portion of a street are hereby declared to be public
streets and dedicated to the public use.

a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that said Council hereby acknowledges receipt of assurance from the subdivider, CHRISTIANA COMMUNITY BUILDERS, that said subdivider will comply with the Affirmative Marketing Program as outlined Document No. 757438, on file in the Office of the City Clerk, and in reliance on said assurance does hereby accept the final map of VILLA MESA UNIT NO. 1.
