

RESOLUTION No. R-254949 (R- 82-337)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of those street and drainage easement deeds of TIERRASANTA NORTE, a California partnership, and THE SAN DIEGO UNIFIED SCHOOL DISTRICT OF SAN DIEGO COUNTY, executed in favor of The City of San Diego, bearing dates of June 18 and August 4, 1981; and June 3, 1981, respectively, copies of which are on file in the office of the City Clerk as Document Numbers RR-254949-1, RR-254949-2 and RR-254949-3 granting to said City easements for street and drainage purposes, across those portions of Parcels 2 and 5, Page 8547 of Parcel Maps, and Block 14 of the Resubdivision of Lots 14, 16, 18, 19, and 20, Rosedale Tract, as more particularly described in said deeds; be, and the same is hereby approved; and the land therein conveyed for a public street is hereby dedicated as and for a public street, and the same is hereby named ANTIGUA BOULEVARD.

That the City Clerk is hereby authorized and directed to cause said deeds and a certified copy of this resolution attested by him under seal, to be recorded in the office of the County Recorder.
