APPROVING MAP OF VILLA MESA UNIT NO. 2 AND ACKNOWLEDGING  
RECEIPT OF SUBDIVIDER'S ASSURANCE OF COMPLIANCE WITH THE  
AFFIRMATIVE MARKETING PROGRAM

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by LEROY C. BODAS, a Registered Civil engineer, entitled "VILLA MESA UNIT NO. 2 Being a subdivision of a portion of Parcel 2, in the City of San Diego, County of San Diego, State of California, as shown at page 8547 of Parcel Maps, filed in the office of the County Recorder of San Diego County, March 19, 1979.," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Via Maltaso for public purposes, and said street is hereby declared to be a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements listed in paragraphs 1 and 2 of the Owner's certificate, as shown on this map and subject to the conditions set forth thereon.



BE IT FURTHER RESOLVED, that said Council hereby acknowledges receipt of assurance from the subdivider, CHRISTIANA COMMUNITY BUILDERS, that said subdivider will comply with the Affirmative Marketing Program as outlined in Document No. 757438, on file in the Office of the City Clerk, and in reliance on said assurance does hereby accept the final map of VILLA MESA UNIT NO. 2.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
