WHEREAS, said easement is no longer necessary and has not been needed since 1979, and it is therefore appropriate to quitclaim the easement to the owner of the property; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Mayor and City Clerk are hereby authorized to execute a quitclaim deed quitclaiming the City's interest in a temporary road easement in Lot 2 of TORREY KNOLLS PARK to RIVER VIEW DEVELOPMENT, a limited partnership, the form of which deed is on file in the office of the City Clerk as Document No. RR-254955-1.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to deliver the deed, when executed, to the Property Department for further handling.
