BE IT RESOLVED, by the Council of The City of San Diego, as follows:


That the City Manager is authorized and directed to execute, for and on behalf of The City of San Diego, an agreement, a copy of which is on file in the office of the City Clerk as Document No. RR-254957, with GARY ROSE WEBER, Consultant, to prepare a revision to the Mid-City Development Plan.

BE IT FURTHER RESOLVED, that there shall be transferred the sum of \$15,000 from 1980 CDBG Contingencies-Fund 18516, Dept. 5970, Org. 7001, to Fund 18516, Dept. 5971, Org. 7106 (Mid-City Plan), and the sum of \$24,500 from 1981 CDBG Contingencies-Fund 18517, Dept. 5994, Org. 9401 to Fund 18517, Dept. 5985, Org. 8503 (Mid-City Plan).

BE IT FURTHER RESOLVED, that a sum not to exceed \$39,500 is authorized to be expended pursuant to the aforesaid agreement.
