BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and directed to acquire said property.

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$1,900,000 as payment for said property and related costs from Open Space Park Facilities District No. 1 Bond Fund 79102 is hereby authorized and approved.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to accept the deed to said property without further Council action.
