

RESOLUTION NUMBER R- 254978

Adopted on SEP 14 1981

WHEREAS, Section 8330 et seq. of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where for a period of five consecutive years the streets have been impassable for vehicular travel and during such period no public money has been expended for maintenance; and

WHEREAS, an unnamed 40-foot street has been impassable for five consecutive years and no public money has been expended for maintenance; and

WHEREAS, the unnamed street is not accurately set forth in the deed and cannot be plotted; and

WHEREAS, only that portion of the unnamed street within the subdivision boundary of BRIARWOOD VISTAS is being vacated; and

WHEREAS, those properties adjoining the street to be vacated will continue to have access or will be accessible because of the street system being dedicated with the approval on this date of BRIARWOOD VISTAS: NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the unnamed street recorded August 24, 1896 in Book 257, page 160 of Deeds, as more particularly shown on Drawing No. 15124-B on file in the office of the City Clerk

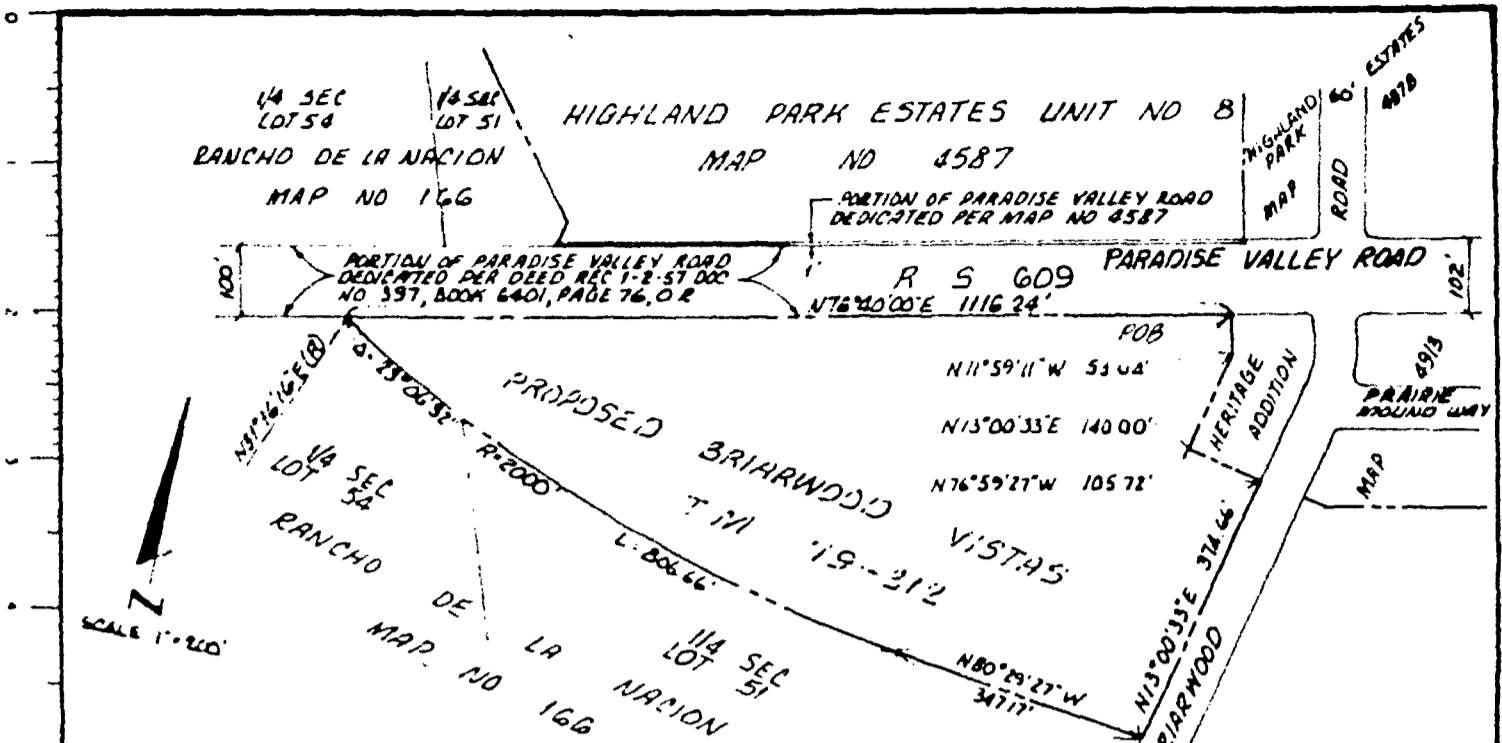
as Document No. RR- 254978 , which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

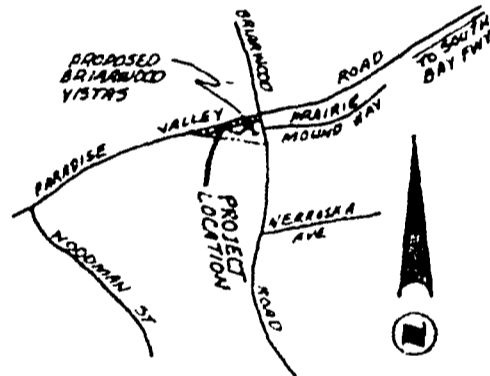
