

RESOLUTION No. R-254983 (R- 82-311)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of GENSTAR DEVELOPMENT INC., a New York corporation, executed in favor of The City of San Diego, bearing date of December 19, 1980, a copy of which is on file in the office of the City Clerk as Document No. RR-254983-1, granting to said City an easement for public street purposes over, along and across that portion of Quarter Section 78, Rancho de la Nacion, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed for public street purposes is hereby dedicated as and for a public street, and the same is hereby named BULLOCK DRIVE.

BE IT FURTHER RESOLVED, that the acceptance by the City Manager of that street easement deed of the SAN DIEGO UNIFIED SCHOOL DISTRICT OF SAN DIEGO COUNTY, executed in favor of The City of San Diego, bearing date of December 10, 1980, a copy of which is on file in the office of the City Clerk as Document No. RR-254983-2, granting to said City as easement for public street or highway purposes over portions of 1/4 Section Lot 54 and 77 of Rancho de la Nacion, Map No. 166, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed for public street purposes is hereby dedicated as and for public streets, and the same are hereby named BENJAMIN HOLT ROAD and PARADISE VALLEY ROAD.

That the City Clerk is hereby authorized and directed to cause said deeds and a certified copy of this resolution attested

by him under seal, to be recorded in the office of the  
County Recorder.
