LIKER, husband and wife, executed in favor of The City of San Diego, bearing date of April 17, 1981, a copy of which is on file in the office of the City Clerk as Document No. RR- 254990, granting to said City a storm drain easement over, under, along and across portions of Lots A and D in Block 225 of Mission Beach, Map No. 1809, as more particularly described in said deed, be and the same is hereby approved.

BE IT FURTHER RESOLVED, that this resolution shall be and become effective upon written approval of the State Coastal Commission, and in the event of such approval is not given on or before September 30, 1982, this resolution shall be void and of no further force or effect.
