

RESOLUTION No. R- 254992 (R-82-297)


Adopted on SEP 14 1981

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of CHARLES D. BRENNAN, a married man, as his sole and separate property, executed in favor of The City of San Diego, bearing date of June 15, 1981, granting to said City an easement for street purposes over, along and across that portion of the East Half of Lot 59 of Subdivision No. 5, Lot 12, Rancho Mission, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named JAMACHA ROAD.

That the City Clerk is hereby authorized and directed to cause said deed and a certified copy of this resolution attested by him under seal, to be recorded in the office of the County Recorder.
