
Adopted on SEP 14 1981

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that alley easement deed of THE ROMAN CATHOLIC BISHOP OF SAN DIEGO, a corporation sole, executed in favor of The City of San Diego, bearing date of August 31, 1981, a copy of which is on file in the office of the City Clerk, granting to said City the permanent easement and right-of-way for an alley and incidents thereto, over, under, upon, along and across that portion of Lots 11 and 12, Block 410 of H. C. Skinner's Addition, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed for an alley is hereby dedicated for public purposes.

That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
