BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of those street easement deeds of STATE FARM MUTUAL AUTOMOBILE INSURANCE COMPANY, a corporation, and RANCHO EX MISSION INVESTORS, a California general partnership, executed in favor of The City of San Diego, bearing dates of June 25, 1981 and July 1, 1981, respectively, granting to said City the permanent easement and right-of-way for a public street and incidents thereto over, under, upon, along and across a portion of Lot 1 of Map No. 6837, and a portion of Parcel 1 of Map No. 7494, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named CAMINO DEL RIO NORTH.

That the City Clerk is hereby authorized and directed to cause said deeds and a certified copy of this resolution attested by him under seal, to be recorded in the office of the County Recorder.
