

RESOLUTION NUMBER R- 254996

BE IT RESOLVED, by the Council of The City of San Diego as follows:

WHEREAS, D.S.W. VALETA GROUP and MICHAEL B. WHITLOCK has requested an exchange of sewer easements; and

WHEREAS, the City Manager has certified that the values of the property rights to be exchanged are equal; and

WHEREAS, the easement to be acquired will serve the same use and purpose as the easement to be quitclaimed by the City; NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the acceptance by the City Manager of that deed of D.S.W. VALETA GROUP and MICHAEL B. WHITLOCK executed in favor of The City of San Diego, bearing date of May 7, 1981, conveying to said City a sewer easement in Parcel 1, Parcel Map 10146, as more particularly described in said deed, is hereby approved. (On file in the Clerk's Office as Document No RR-254996-1 .)

2. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, quitclaim deeds, copies of which are on file in the office of the City Clerk as Document Nos. RR- 254996-2 and RR- 254996-3, quitclaiming to D.S.W. VALETA GROUP and MICHAEL B. WHITLOCK, all of the City's right, title and interest in the sewer easement in Parcel 1, and quitclaiming to COLLIER PARK ASSOCIATES the sewer easement in Parcel 2, all in Parcel Map 10146, as more particularly described in said deeds.

3. That the City Clerk is hereby authorized and directed to deliver both deeds, and a certified copy of this resolution to the Engineering and Development Department for further handling.
