RESOLUTION NUMBER R- 255000

WHEREAS, since the City's REGY Program has operated a year round Youth Employment Program under agreements with the San Diego Regional Employment and Training Consortium (RETC); and

WHEREAS, the current program was approved by the Council on September 19, 1980 and scheduled to operate from October 1, 1980 through September 30, 1981; and

WHEREAS, due to a restructuring of the RETC contracting cycle, future year-round contracts will operate from December 1 through November 30; and

WHEREAS, this creates a two month funding gap this year and RETC has offered the City \$275,000 to extend REGY's current contract for two months until the beginning of the new contract period; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement, modifying Contract Number 8013-8113, with the San Diego Regional Employment and Training Consortium (RETC) allowing the San Diego Regional Youth Employment (REGY) to extend the year-round program under Title II B of the Comprehensive Employment and Training ACT (CETA) to operate for the additional period from October 1, 1981 through November 30, 1981, at an increase in funding level from \$2,052,000 to \$2,327,000 under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR - 255000.
