WHEREAS, the Council has heretofore adopted Ordinance No. O- 15587


declaring that there is a need for the Industrial Development Authority of the

privileges, duties, liabilities, disabilities, and immunities vested in the
Board of Directors of such Authority by the Act shall be vested in this Council
as such Board of Directors.
