

RESOLUTION NUMBER R- 255017

A RESOLUTION APPROVING THE FEES TO BE CHARGED COMPANIES MAKING APPLICATIONS TO THE CITY OF SAN DIEGO FOR FINANCING UNDER THE CITY OF SAN DIEGO ECONOMIC DEVELOPMENT REVENUE BOND LAW.


WHEREAS, the Council has heretofore adopted Ordinance No. O-15587 declaring that there is a need for the Industrial Development Authority of the City of San Diego created by the California Industrial Development Financing Act, California Government Code Sections 91500 et seq. (the "Act"), and declaring that such Authority shall function in the City of San Diego; and

WHEREAS, Section 97.0204 of Ordinance No. O-15586 provides that the City is authorized to charge participating parties application, commitment, financing, and other fees, in order to recover all administrative and other costs and expenses incurred in the exercise of the powers and duties conferred by the City of San Diego Economic Development Revenue Bond Law; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the City Manager is hereby authorized to charge non-refundable fees as set forth in Attachment 3 of City Manager Report 81-285, on file in the office of the City Clerk as Document No. RR-255017.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to make such adjustments to these fees as determined necessary to fully recover City costs of processing applications for financing under the City of San Diego Economic Development Revenue Bond Law.
