
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bid of SAN DIEGO KAWASAKI is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of TWENTY-ONE (21) POLICE MOTORCYCLES (Kawasaki KZ1000C4), Sixteen (16) without sirens at a cost of \$4,400.00 each, and five (5) with sirens at a cost of \$4,665.00 each, for a total cost of \$93,725.00; terms net 30 days, plus sales tax, less trade-in allowances as follows:
