VACATION OF A PORTION OF OPEN SPACE EASEMENT IN LOT 73 OF  
LUSK INDUSTRIAL PARK UNIT 1, MAP 9694.

WHEREAS, it is proposed that a portion of open space easement in Lot 73 of  
Lusk Industrial Park Unit 1, Map 9694, be vacated; and

WHEREAS, there is no present or prospective use for a portion of open  
space easement in Lot 73 of Lusk Industrial Park Unit 1, Map 9694, either for  
the public street system for which the right-of-way was originally acquired or  
for any other public use of a like nature that can be anticipated; and

WHEREAS, the public will benefit from the vacation through improved  
utilization of land; and


WHEREAS, the vacation or abandonment is not inconsistent with the General  
Plan or an approved Community Plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, California, that  
a portion of open space easement in Lot 73 of Lusk Industrial Park Unit 1, Map  
9694, as more particularly referred to in Resolution of Intention No. R-  
254815, is unnecessary for present or prospective open space purposes.

BE IT FURTHER RESOLVED, that a portion of open space easement in Lot 73 of  
Lusk Industrial Park Unit 1, Map 9694, as more particularly shown on Drawing  
No. 15357-B on file in the office of the City Clerk as Document No. RR-  
254815, which said Drawing is attached hereto and made a part hereof,  
be, and the same is hereby ordered vacated.

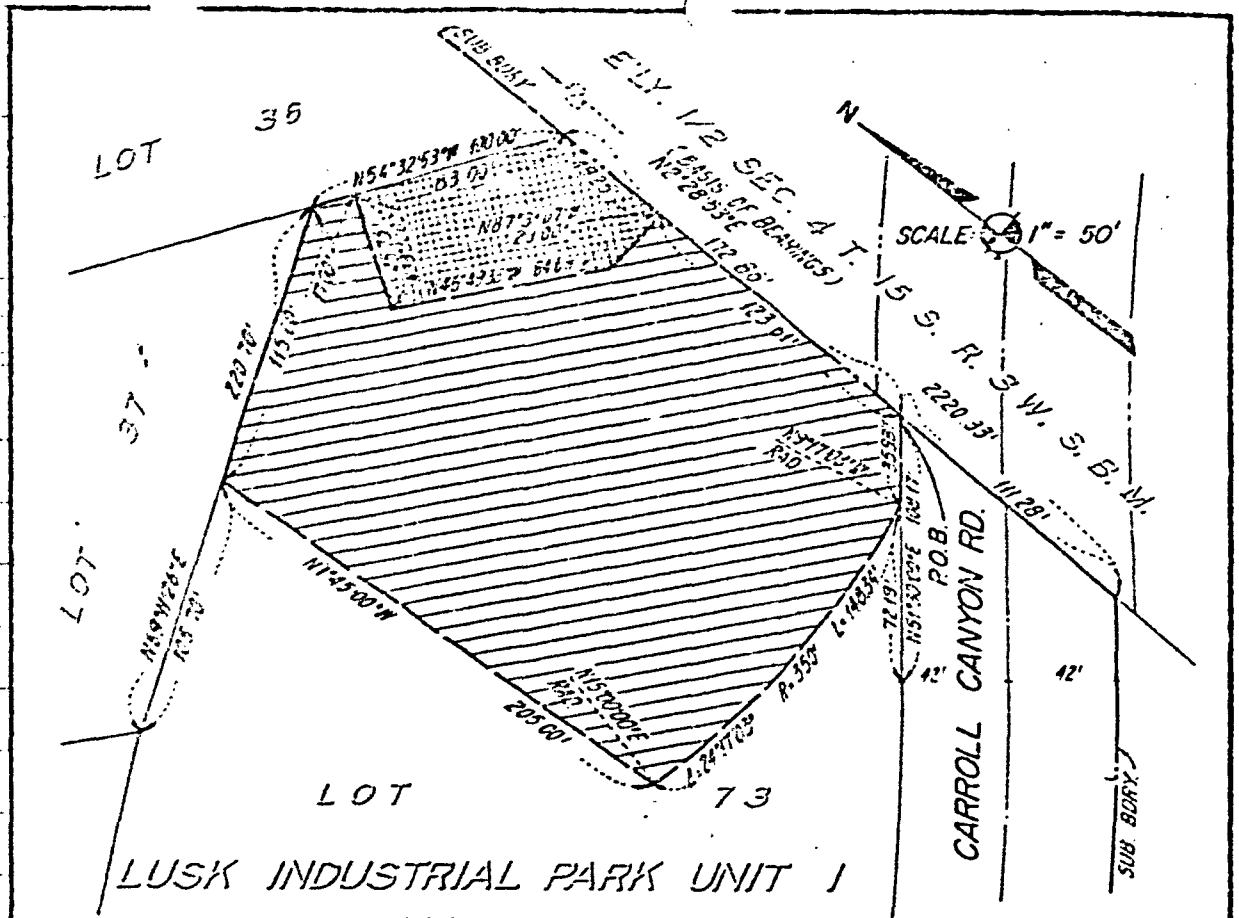
BE IT FURTHER RESOLVED, that the City Clerk shall cause a certified copy

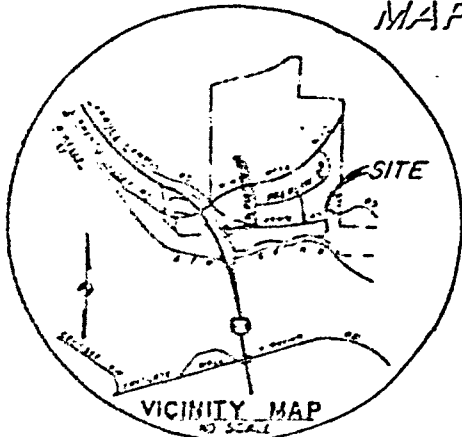
