BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the SAN DIEGO REGIONAL EMPLOYMENT AND TRAINING CONSORTIUM (RETC) to accept no more than \$406,918 in CETA administrative funds during the period October 1, 1981, through March 31, 1982, to conduct audits and other reports associated with terminating the Title II and Title VI Public Service Employment Programs of the City and eight City subagents; said agreement is on file in the office of the City Clerk as Document No. RR- 255044-1.

BE IT FURTHER RESOLVED that the City Manager be, and he is hereby authorized and empowered to execute and modify as necessary, for and on behalf of said City, agreements with the following City subagencies for audit and "close out" activities. The total amount of such agreements shall not exceed \$242,562.00. Said agreements are on file in the office of the City clerk under document numbers listed below:


