WHEREAS, the Water Utilities Department of The City of San Diego owns an approximately 70 acre parcel of property in the North Chollas area Northerly of College Grove Drive; and

WHEREAS, said property is presently proposed for utilization as a sanitary fill site and said 70 acre parcel has an appraised value of \$2,300,000; and

WHEREAS, use of said property as a sanitary landfill site requires reimbursement to the Water Utilities Department and the City proposes to exchange a portion of general City owned property for said site; and

WHEREAS, the City owns approximately 245 acres of property located in the intersection of Pomerado and Beeler Canyon Roads known as Site 805; and

WHEREAS, said 245 acre parcel has an appraised value of \$3,300,000; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of The City of San Diego that the Water Utilities Department's of The City of San Diego is hereby granted 70 percent ownership of Site 805 in exchange for the Water Utilities Department's interest in the approximately 70 acres of Water Utilities property needed for the proposed North Chollas Sanitary Landfill.
