Adopted on SEP 28 1981

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the addition of Capital Improvement Program Project 20-107.5 - Vest Pocket Park - Gaslamp Historic District to the Fiscal Year 1982 Capital Improvement Program, is hereby authorized and approved; and

BE IT FURTHER RESOLVED, that the transfer of \$287,000 from Capital Improvement Program 20-007 - Vest Pocket Parks to Capital Improvement Program 20-107.5 and \$52,550 from Capital Improvement Program 39-032.4 Gaslamp Quarter Historic District - Restoration - Phase IV to Capital Improvement Program 20-107.5 to finance the development of the park, is hereby authorized; and

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to prepare plans and specifications and solicit bids for the work necessary for the development of a Vest Pocket Park in the Gaslamp Historic District on a 50 foot by 100 foot lot, located at 4th Avenue and Island Street, subject to City Council approval of necessary contracts and agreements for the park development; and

BE IT FURTHER RESOLVED, that the expenditure of funds not to exceed \$371,300 for the park development including not to exceed \$258,000 for acquisition and relocation costs and not to exceed \$113,300 for demolition, site clearance, house moving, park design and construction, is hereby authorized.
