BE IT RESOLVED, by the Council of The City of San Diego as follows:


That the bid of UNIVERSITY FORD is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of FIFTY-FIVE (55) COMPACT POLICE SEDANS (Ford Fairmount with 200 CID V-6 engine), forty-three (43) for a cost of \$6,905.38 each, twelve (12) with additional equipment for a cost of \$7,048.80 each for a total cost of \$381,516.94; terms net 20 days, plus sales tax, less trade-in allowance as follows:
