

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bid of ENVIRONMENTAL CARE, INC. is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing COMPLETE LANDSCAPE MAINTENANCE OF FORTY (40) SELECTED SITES (EASTERN DIVISION, PARK AND RECREATION DEPARTMENT) as may be required for a period of twelve (12) months beginning October 16, 1981 through October 15, 1982 at a cost of \$5,215.00 per month, for a total cost of \$62,580.00; terms 5% 20 days, with option to renew contract for two (2) additional one (1) year periods with price escalation not to exceed 12% the first option year and 10% the second option year.
